GAS SUPPLY REGULATION 1997

"Responsible Person" in a premise refers to the individual that holds a licence (Individual Gas Licence) or a user or an occupant, the owner of the premise or an individual with full authority assigned by the user or occupant towards the responsibility in managing the gas pipeline or any gas installation on the premise.

The task assigned from the "responsible person" according to the Gas Supply Act 1993 / The Gas Supply Regulations 1997 are :

Regulation 62[2] - To ensure that the permanent gas pipeline is clearly identified during the duration of its use.

Regulation 63[2] - If there were or suspected gas leakage occurs on the premise ground, necessary action must be taken to stop the gas supply in order to avoid further leakage.

INTRODUCTION

To cater the needs of the officers by employing a sense of responsibility as well as ensuring gas operation safety and continuous monitoring of gas pipeline system.

Responsible person is also required to ensure that the gas pipe is clearly identified and to take necessary actions if there were has leakage, ensuring all safety standards are followed prior to gas supply and also to equipped them with the ability to manage records.

ENTRY QUALIFICATION

This course is open for anyone from different fields or background that may deemed appropriate for the gas safety in building.
